## **Priority Projects**

#### **Road Asset Data Standard**

The existing Knowledge Sharing Platform functionality is currently being extended to support automated reporting. The reporting functionality will be in place by June 2021 for user testing, with a proof of concept completed by September. Marsden Jacob have been engaged to develop costs and benefit estimates for a comprehensive Data Quality Improvement Program.

#### **Temporary Traffic Management**

An implementation project manager has been appointed to develop an implementation plan for consideration and endorsement by the Temporary Traffic Management Task Force.

#### Harmonisation of Funding for Class 1 and 2 Heavy Vehicles Permit Application Assessments

Austroads is undertaking a nationwide review of the funding mechanisms for Class 1 and 2 heavy vehicles permit application assessments to identify options for national harmonisation. Frontier Economics has been engaged to undertake Stage 1 of this project. The project will be led by the Austroads Freight Task Force under the Transport Network Operations Program.

#### **Austroads Technical Specifications**

To date, 20 technical specifications have been published, 28 are out for consultation with industry groups, and six are with jurisdictions for feedback. The Austroads Technical Advisory Group (ATAG) has approved the development of an additional 20 specifications.

#### Recycled materials in roads

Austroads is undertaking five projects that could help to improve the use of material diverted from the waste stream in roads and road assets:

- AAM6255 Use of recyclable materials in roads and road assets (now complete)
- APT6249 Protocol for the assessment of waste materials in road surfacing (expected completion October 2021)
- APT6311 Use of crushed glass in road infrastructure (expected completion mid-2021)
- APT6305 Use of road-grade recycled plastics for sustainable asphalt pavement (expected completion early-2022)
- APT6173 National specification for crumb rubber binders in asphalt and seals (expected completion October 2021).

# Review of the National Heavy Vehicle Driver Competency Framework: Stage 3

This project aims to develop an exemplar licensing framework for national implementation. The board approved the development of heavy vehicle hazard perception test materials. The project is due for completion in 2022.

#### Overseas Driver Licensing Policy Review: Stage 2

This project aims to ensure Australia and New Zealand maintain best practice licensing arrangements for overseas drivers for improved road safety outcomes. The project is on track to be completed by the end of 2021.

### A National Approach to Measuring Non-fatal Crash Outcomes: Stage 2

This project will use data linkages to improve the measurement of non-fatal hospitalised road injuries in Australia. Austroads has obtained the appropriate ethics permissions and data custodian approvals for all Australian states and territories, except Western Australia. This project, and another project dependent on the data, has been delayed by the inability to access to Western Australia's health data.

#### **Directors**

This was the last Board meeting for Robyn Seymour, Deputy Secretary Network Planning and Head of Road Safety, Department of Transport Victoria, and Adrian Beresford-Wylie, Executive Director, Australian Local Government Association. Neil Scales thanked them both for their valuable contribution to the Austroads' Board.

#### Staff

Michael Nieuwesteeg has been appointed Program Manager, Road Safety and Design. Michael commenced on 22 March 2021 and will be based in the Department of Transport in Melbourne.

Paul Davies was appointed Program Manager, Future Vehicles and Technology, Environment and Sustainability. Paul commenced on 24 March 2021 and is based in the TCA offices in Melbourne. Shortly after commencing, Paul was appointed to act in the General Manager Operations role for six months. Vibeke Matthews of Queensland TMR has been seconded to the Program Manager Role for the period. She commenced on 3 May 2021.
